1.1 This bid and all contracts emanating there from will be subject to the general conditions of contract issued in accordance with Treasury Regulation 16A published in terms of Public Finance Management Act (PFMA), 1999 (Act 1 of 1999). This Bid is issued in terms of the National Treasury Contract General Conditions of Contract July 2010.
