# Legal Origins of the BOA



EA 12 August 2013. Conditions 50 to 60 of the EA (Amendment 2)

Give effects to EA: Condition 50:

"A legal Agreement must be signed between DENC and Black Mountain Mine (BMM) within 1 year after receipt of a positive RoD "from DENC. Failure to do so will result in the withdrawal of the positive RoD"

Signed between DENC and BMM on 16 October 2014.



# Rationale for the approach adopted in the BOA



BOA is the result of many **biodiversity trade-off and compromises** - in favour of the project going ahead.

Under a strict application of the mitigation hierarchy and internationally recognised offset best practices and policies, this project should not have been approved, as it will result in the loss of irreplaceable biodiversity.

Considering the economic and social benefits from the project, a compromise was agreed.



# Rationale for the approach adopted in the BOA



The BOA contains a pragmatic compromise in that BMM would be required to purchase 7 farms from a list of 12 farms pre-selected (Clause 6 of BOA) and the commitment to protect selected BMM properties, containing key critically endangered species (Clause 5 of BOA).

Impossible or too expensive for BMM to purchase properties to compensate for all the sub-habitats requirements as per the Biodiversity Offset Report.

Not meeting strict like for like requirements, was deemed acceptable due to its specific contribution to **supporting a landscape approach towards conservation in the Bushmanland landscape.** 

This approach informed the Vedanta/BMM requirement for no net loss.



**Background about IUCN Role** 



Since 26 Feb 2013: IUCN has a collaboration agreement with BMM to support them with their biodiversity management approach, including the BOA.

IUCN was supposed to be the auditor for the first audit, but it was agreed at 1<sup>st</sup> SC that IUCN had a conflict of interest and it was better to use another organisation to conduct the audit.

SC decided that IUCN should however remains as an observer for the SC and LC, which has been the case since 2016. it was also decided that IUCN will support the SC with the independent audit process, to ensure a level of oversight.

### **Objective:**

- To improve the efficiency of the SC and LC regarding the implementation of the BOA;
- To address the Independent Auditors finding regarding Clause 3.1 "to co-operate in good faith in implementing & executing BOA with focus on ongoing protection & maintenance of the BMM properties (Clause 5)";
- Recommended by IR that this Improvement Plan needs to presented and approved by SC;

### General duties of the parties (Clause 3):

- Parties agreed to continue to act in good faith with a sincere intention to deal fairly with each other;
- "Good faith" the honest & transparent dealing and implementation of BOA through open, transparent & written communication;
- Committed to proper, transparent & honest communication & timeous execution of tasks as per BOA

#### Handover to successors:

- The turnaround of human resources at DENC & BMM has contributed to delays in the implementation of BOA;
- The parties undertake to ensure that current employees will do a comprehensive handover.



### **1.2 Document control:**

- Improvements regarding document control/archiving of all documentation are required to ensure easy access by both parties, successors & all members of the LC & SC;
- Central document control system is required;
- This will include, but not limited to the following:
  - Biodiversity Offset Agreement and all Annexures;
  - Steering and Liaison Committee Meeting documentation:
    - Final agendas; Attendance registers; Presentations; Approved/signed-off minutes; Action trackers
  - Roles and responsibilities;
  - Audit Reports;
  - Terms of references;
- Appointment of a dedicated and independent secretariat to assist both the LC & SC to assist with:
  - $\circ~$  Compilation, documentation and management of the above; and
  - $_{\odot}\,$  Roles and responsibilities of the secretariat (discussion and decision).





### Rules of engagement (for approval at SC)

- Formal written communication

    - Implementation BOA;
    - Amendment of the BOA if / when required;
    - Reporting on any issues / disputes that may require clarification;
    - Any other matter that require written communication between the parties;
  - Any new or proposed EA process (both BMM and DENC) to ensure alignment regarding any BMM & external developments surrounding BMM & Offset areas.
    - Acknowledge & provide each other with written proof of receipt of DBARs & related documents submitted within the BMM and Offset areas; and
    - DENC needs to comment within the required time period on any EA processes.
- Acknowledgement that formally written communication (above) was received with a written response 72 hours or as agreed

# **Rational for Audit**



### Part of the BOA

#### Independent review of the implementation of this Agreement

- 14.7. A review of this Agreement by an Independent Auditor or team of Independent Auditors shall be undertaken every five (5) years with the first review to be undertaken upon the expiry of the five (5) year period calculated from the date of signature of this Agreement.
- 14.8. The purpose of the review contemplated in clause 14.7 shall be to:
- 14.8.1. determine compliance with the provisions of this Agreement by the Parties;
- 14.8.2. determine the adequacy of the implementation of the Biodiversity Offset in terms of this Agreement; and
- 14.8.3. provide recommendations to the Steering Committee on *inter alia* improving and/or enhancing the implementation of the Biodiversity Offset, including recommendations to adjust the financial provisions in terms of clause 10, where required.
- 14.9. The Parties shall co-operate in good faith with the Independent Auditor or team of Independent Auditors in order to enable the Auditors to achieve the objectives in clause 14.8.

# **Audit Process**



The first independent review (IR) or independent audit (IA), was undertaken from August 2019 to November 2019.

The first audit report, December 2019, identified various implementation challenges and interpretation issues to be addressed by the parties.

It was therefore agreed by the parties that a follow-up audit would be conducted in March 2020 to revisit work in progress regarding the closure of partially compliant and non-compliant findings of the original audit and the implementation of recommendations made by the Independent Auditor.

The follow-up Audit Report was finalised in April 2020.

### Discussion and DC 7: on implementation for each recommendations

1	Annual Independent Audits instead to 5 yearly - highlight non-conformances as these arose.
2	Increase number of Steering Committee meetings from 2 to 3 annually - to address non-compliance issues as they arise.
3	Define "protection of biodiversity & ecological functioning of the surface areas of the BMM properties" (set-asides) to clarify conservation commitments on these areas.
4	Restrict further prospecting on BMM set-asides without written agreement by both implementing parties.
5	Amend BOA to state that BMM needs to formally notify DENC when it intends to submit an application for EA to prospect or mine on any of its set-aside areas.
6	Include commitment to undertake specialist studies that demonstrate prospecting activities will not negatively impact on the ecological functioning of sensitive biodiversity on the BMM set-aside areas as part of BAR submissions in advance of applications for EA.
7	BMM to appoint a specialist team including appropriate biodiversity and legal expertise to assess the necessity for an additional BOA versus an amendment to the existing BOA to address prospecting on set-aside areas for Gamsberg SE and Big Syncline properties. This was a condition of the exploration EA.
8	Clause 10.6 & 10.7 refer to the "5 year period" in respect of which payments are due. If by amending the Second Time Period, the parties also intended to amend clauses that refer to a "five year period", then it is recommended that the parties amend the BOA to reflect their intention.
9	Revise Clause 10.9 - payments are only required following formal appointment of Management Authority
10	Reconsider structure of SC to facilitate decision-making and follow-up on actions and responsibilities of the implementing parties.
11	Amend the BOA to clarify distinct roles of LC & SC (overlapping of functions)
12	Amending the BOA to include additional punitive conditions where obligations have not been met.
13	Consider including legal and/or technical experts where committee members cannot understand the BOA and implementation requirements.

  - Technical experts recognised that some mining or/and exploration activities could take place under strict conditions;
  - DENC insisted that due to their legal mandate & role as biodiversity custodian, they cannot, legally, approve any activities whether exploration or mining on the listed BMM properties;
  - DENC indicated that one option would be for BMM to elevate the discussion to national level with the DEA & DMR to seek their approval;
  - Such an approval would have to be informed by a broader socio-economic and biodiversity strategy developed by BMM;
  - BMM to incorporate all planned projects and related impacts from BMM expansion in the region, taking a cumulative and integrated approach, and it would have to outline the proposed commitments of BMM to address such impacts, through the mitigation hierarchy & the full suites of compensation measure;
  - BMM have commence with compilation of Broader Biodiversity Strategy, taking all proposed developments into consideration (Gamsberg South, East, Kloof and Big Syncline – u/g; Big Syncline, Swartberg o/c; Smelter, SEZ);
  - Way forward discussion by all
